A Meeting of the Executive Committee was held at the Offices on Friday, the 4th of January, at 5 p.m., Her Royal Highness the President in the Chair.

A most interesting letter has been received from Miss Wild, Matron of the Grey Hospital, King William's Town, Cape Colony, and enclosing two photographs, the one of a witch doctor, the other of the Grey Hospital which was erected by Sir George Grey for the purpose of breaking the belief of the natives in witch doctors by placing skilful medical and surgical treatment within their reach, free of charge. "The success of the Institution," Miss Wild writes, "is proved by the number of natives who travel hundred of miles to seek medical and surgical aid, showing that the Kaffir people are breaking through their race prejudices and acknowledging the superiority of scientific treatment of ordinary diseases." It was only in 1892 that trained Nurses were introduced into the Hospital, of which Miss Wild was the first.

Miss Elizabeth Turner is just appointed Charge Day Nurse for the Redhill and Reigate Cottage Hospital.

A Meeting of the Educational Sub-Committee was held on Tuesday, the 19th ult., at which the final details of the Second Course of Educational Lectures were arranged. The Course is to begin on February 4th, 1895. Fee 2 guineas the complete series, or half a guinea each separate course.
