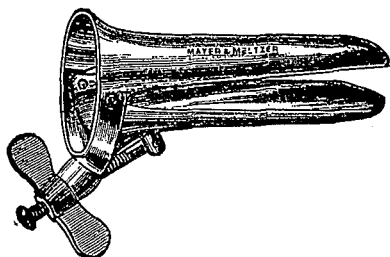

day. The simplest and the best specula are of two shapes, the "duck-bill" and the "cylindrical." The former (Fig. 2) is chiefly used in operations, in order to draw back the perinæum and the posterior wall of the vagina; the latter, of which the Fergusson

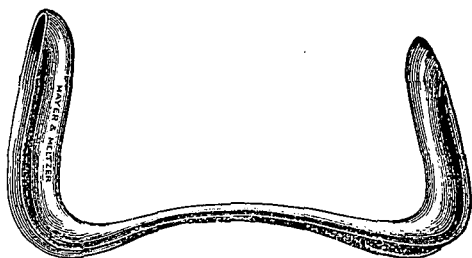

speculum (Fig. 3) is the type, consists of a hollow tube of glass or celluloid, coated inside with silvered glass, which thus reflects the necessary light for inspection.

tion. For all practical purposes, therefore, the Fergusson speculum is the one which the Nurse will most frequently, if not invariably, be called upon to use, and attention may, therefore, be confined to this. There are various sizes; the one chosen should be such as slightly to distend the vaginal walls, and thus permit any abrasion, or ulceration, of its surface to be observed. In all gynaecological treatment, the Nurse will find it better to place the patient in what is known as the Marion Sims position, that is to say, on her left side with the left arm behind the back, the body face downwards, and the knees drawn well up. If injections are to be used, it is also well to place a pillow covered with a waterproof and draw sheet underneath the hips, so as to tilt the body still lower than the pelvis.
