THE Duke and Duchess of DEVONSHIRE on Saturday afternoon formally opened the new Royal Infirmary at Derby, the foundation-stone of which was laid by the Queen three years ago. The building stands on practically the same site as the old, and covers an area of 14 acres. The old buildings were condemned on account of their bad sanitary arrangements. Up to the present, £88,000 has been expended on the new Infirmary, including a gift of £12,000 from Mr. Walter Evans. On Saturday, thanks to a further sum of £12,000 from Mr. George Henry Strutt, the debt of the Institution was well-nigh extinguished. It is estimated that over £100,000 will be required to complete the plans and furnishings. The blocks still to be erected consist of a children's ward and an ophthalmic ward. It is claimed that the Hospital, which was designed by Messrs. Young and Hall, of London, is one of the most perfect in the kingdom.
