Kim Hoolahan, Medical Team Manager, Cega/Charles Taylor

Talk title: The role of the Medical Case Manager

Summary

- 1: Brief biography of how I came to be Manager of 23 medical nurse case managers and 9 doctors.
- 2: Facts and figures of the medical team and number of repatriations in 2024 3: What we do in the office: Medical calls. Authorising procedures. Challenging hospitals if needed. Setting up repatriations. Calls to patients to answer queries. Booking UK beds. Assessing insurance cover.
- 4: The qualities and experience needed to be a medical case manager: Broad range of medical knowledge. ICU and ED preferred. Ability to multitask. Ability to prioritise. Great work ethic. Team player. Empathy for patients/relatives away from their usual support network. Clear and logical thought processes when assessing insurance cover.
- 5: The challenges of the role. Keeping our patients safe in areas with inadequate medical facilities. Obtaining information from overseas medical staff.

 Overcoming language barriers. Awareness that the travel companion may also be vulnerable. Obtaining UK beds at a time when the NHS is struggling with capacity. Dealing with multiple insurance companies with often very different stances

Learning outcomes

- 1. What the role of the office nurse involves.
- 2. The qualities and experience needed to become a good medical case manager.
- 3. The challenges of the role.

Biography

Kim Hoolahan qualified as an RGN in 1981 at the Middlesex Hospital in London. After working in operating theatres and gynaecology, she worked in the ICU at the National Hospital for Nervous diseases, Queens Square, where she took her ENB 100 course. Kim then worked in ICU's in Saudi Arabia and Australia, returning to the UK and working as flight/office nurse and ICU nurse in Portsmouth. This included ventilated/ ICU repatriations in air ambulances as well as commercial repatriations. Kim was then promoted to a managerial position and is now medical team manager for 23 nurses and 9 doctors.

Adam Booth, Company Director / Advanced Paramedic Practitioner, Repatriation Medical Services Ltd/ South East Coast Ambulance Service

Talk title: Commercial aircraft medical escort vs Air ambulance

Summary

What is the difference, kit, stretcher, patient comfort.

Learning outcomes

- 1. The difference between the two types of repatriation.
- 2. Pro's and con's.
- 3. Overall best decision for the patient along with financial considerations.

Biography

Adam qualified as RGN in 2004 at Brighton University, during his training he worked as a HCA in the emergency department at Eastbourne district general hospital. On completion he worked as a Staff Nurse in the same department, becoming experienced in all aspects of emergency/urgent care. In 2006 he joined the South East Coast Ambulance Service (Secamb) as part of a pilot program to bring other healthcare professionals into the role of Emergency Care Practitioner, with an aim to reduce hospital admissions and conveyance by ambulance crews. He completed his autonomous practitioner (now the Advanced Paramedic Practitioner) training at St. Georges University, London, this enabled him to gain a great deal of experience working in the pre hospital environment supporting staff both on the road and remotely from the control room, Adam also enjoyed training new staff as a mentor. He was then offered to commence his Paramedic training so he could become dual registered, this was completed at St. Georges University, London. He still works for Secamb on a regular basis. For the past 10 years Adam has been involved in the assistance industry, from remote support to personally completing repatriations worldwide, gaining a broad understanding of all aspects involved in the complexities related to planning a safe repatriation. In 2023 Adam setup his own company Repatriation Medical Services with Georgie who is an active NHS ICU Nurse and part of the RCN forum for critical care and flight nursing.

Clare Whelan, Team Leader, Healix

Talk title: Clinical Considerations for Decision Making

Summary

Effective clinical decision making is critical throughout the medical case management process—from the initial assessment through to case resolution. Clinical decisions evolve as cases develop, influenced by emerging information

and changes in a patient's condition. This dynamic environment highlights the excitement and variability inherent in our work. In this session, attendees will explore case studies that illustrate the decision-making process at various stages of patient care. The presentation will detail the multitude of factors that influence clinical choices and provide strategies to navigate complex cases.

Learning outcomes

- 1. Introduce the clinical decision-making process throughout a patient's journey home.
- 2. Understand and analyse the complexities of international case management

Clare Whelan graduated from University of Liverpool in 2010 and gained experience in Accident & Emergency from various Northwest hospitals. She started her career at Healix International as an ad hoc flight nurse in 2015 before joining as a medical case manager in 2016. She has been a Team Leader since 2019 and oversees a team of nurses and coordinators managing medical care and evacuations for patients unwell away from home.

The session will cover - what is MedAire/MedLink and the nurses role within the Global Response Centre. The aim is for the audience to have a better understanding of MedAire, how they can work with us and utilise us in their various roles as flight nurses.

Biography

Emma is the Deputy Nurse Manager MedAire, based in London International SOS Assistance Centre. Emma started this role in early 2023 when MedAire expanded to London. Prior to that she was working as a Coordinating Nurse for International SOS. Emma maintained her clinical practice in Guys and St Thomas Intensive Care Units, where she was working prior to commencing her role in International SOS in December 2020. Emma has worked across acute medical care and intensive care throughout her career as a nurse and thrived in these busy/fast-paced environments, applying this experience to the wider medical needs of aviation and maritime.

Jason Flanagan, Captain TRI B200 Kingair, Gama Aviation Terry Knights, Captain Kingair B200, Gama Aviation

Talk title: Air Ambulance Insights: Piloting the King Air B200 at Gama Aviation

Summary

This session provides insights into the unique experiences of air ambulance pilots operating the King Air B200, contrasting these with the airline industry. It covers the distinct responsibilities, challenges, and skills required.

Learning outcomes

- 1. Describe the operational differences between air ambulance and airline piloting.
- 2. Explain the skills and decision-making required for air ambulance missions.
- 3. Compare the lifestyle and career pathways in both fields

Biographies

- Jason Flanagan is a highly qualified Captain and TRI on the King Air B200, with a focus on Air Ambulance operations. Accumulating over 3000 hours as pilot in command, he has successfully managed numerous repatriation missions across Europe in the Commercial Aviation sector. His leadership is evident in both single-pilot and multi-crew environments, where he demonstrates strong crisis management and decision-making skills. At Gama Aviation, he is committed to maintaining high safety standards while mentoring upcoming pilots and delivering effective results in challenging operational scenarios.
- Terry Knights moved from his birthplace of New Zealand back in 1988 and after a successful career in the Royal Marines spanning 23 years Terry finally had the opportunity to follow his childhood dream of becoming a pilot. Early in his pilot training he identified that he would like to be an Air Ambulance pilot flying the King Air. After he finished flight training he flew as a jump pilot dropping parachutists off from 10000' down in Cornwall for the Cornish Parachute Club along with another position flying low level with a photographer taking photographs of houses, he also trained as a flying instructor, instructing for the Cornwall flying club, all to gain the required flying hours to move on with his flying career. He also flew as a pilots assistant for an air ambulance company flying out of Exeter, on missions throughout Europe. After two years he had gained the required amount of flying hours to take on the roll as a Captain flying a light twin engined aircraft with the same air ambulance company flying that he flew as a pilots assistant, transferring patients from the Channel Islands and the Isle of Man to the mainland. He now flies out of Bournemouth as a captain on the King Air servicing the same air ambulance contract covering the Channel Islands which he has enjoyed for the past 10 years.

Rachel Benbow, Chief Nursing Officer, International Medical Group (IMG)

Talk title: Roles and responsibilities of the flight nurse

Summary

This session will provide an insight into what the flight nurse can expect from their assistance partner and what the assistance partner should expect from the flight nurse. We will explore requirements and legal obligations of both parties

and some of the more nuanced expectations and challenges around our expectations.

Learning outcomes

- Understand all parties legal obligations of the flight nurse and the assigning organisation (assistance partner)
- Recognise the allocated mission in the context of the financial challenges imposed by the plan wording.
- Discuss the importance of the partnership between the flight nurse community and assistance partners

Talk title: An introduction to aeromedical evacuation in the Royal Air Force

Summary

Aeromedical evacuation (AE) is a critical capability of the Royal Air Force (RAF), ensuring the safe and efficient transport of injured or ill patients by air. This presentation provides an overview of the AE process, including its history, purpose, and operational framework. Key aspects such as the role of RAF medical personnel, specialised equipment, and the challenges of delivering care in an airborne environment will be highlighted. The discussion will include insights into mission planning, patient triage, and the collaborative effort between flight crews and healthcare professionals to maintain high standards of care during transport. Real-world examples will illustrate how AE supports military operations, humanitarian missions, and disaster response, emphasizing its vital contribution to global healthcare delivery. Whether dealing with critical care cases or routine patient transfers, AE in the RAF represents a unique intersection of aviation and medicine. This introduction will provide attendees with a deeper understanding of the complexities and rewards of working in this highly specialised field.

Learning outcomes

- 1. Understand the Role of Aeromedical Evacuation By the end of the session, attendees will identify the key components of aeromedical evacuation and describe its importance in the RAF.
- 2. Identify Key Aspects of Aeromedical Evacuation By the end of the session, attendees will be able to identify the key roles, equipment, and processes involved in aeromedical evacuation within the Royal Air Force.
- 3. Explain the Importance of Aeromedical Evacuation in Operations By the end of the session, attendees will be able to explain the role of aeromedical evacuation in supporting military and humanitarian operations, emphasizing its impact on patient care and mission success.

Biographies

- Rebecca Kinsey, RN(A) MSc ACP, BN (Hons), RAF Flight Nurse Rebecca Kinsey is a nurse with 22 years experience of full-time military service in the Princess Mary's Royal Air Force Nursing Service. She specialised in primary care, earning an MSc in Advanced Clinical Practice and non-medical prescribing in 2024. A trained flight nurse since 2008, Rebecca has served in aeromedical evacuation, operational deployments, and liaison roles. She currently works full-time as a nursing officer for International Medical Group, while also serving as a reserve Flight Nurse for RAF 4626 Aux Squadron and maintaining clinical competency in out-of-hours and emergency care as bank staff for Cardiff and Vale
- Flight Sergeant (FS) Finbow-Wright joined the Royal Air Force in Jun 2001 graduating with a diploma in adult nursing September 2004. A military career spanning 24 years she has worked within the fields of Defence Rehabilitation, Emergency Nursing and Aeromedical Evacuation Liaison Brunei. With operational experience she deployed to Iraq working in the field hospital wards and later in Afghanistan, Emergency Department this led to further deployments on the Medical Emergency Response Team (MERT) in both Afghanistan and Kenya. Currently FS Finbow-Wright works as a flight nurse on the Aeromedical Evacuation Squadron based at RAF Brize Norton undertaking repatriation of injured/sick personnel, dependants and the operational management and logistical co-ordination of other Aeromedical Missions
