### Forum Name:

**Emergency Care Forum** 

### Introduction:

We represent members who work in Urgent and Emergency care by collaborating with other forums and professional organisations. Our priorities are to support and develop staff within UEC in providing safe, effective, and quality care. We focus on best practice and innovations in care identifying areas for development through joint working and shared learning.

### Membership of the forum

The RCN Emergency Care Association currently have 8518 members and is the first-choice forum for 5711 members.

The committee had 6 voting places at Congress. The ECF Committee have appointed 2 new committee members this year. The Steering committee members are from wide range of Emergency care nursing background from prehospital, academia, clinical and management. We also want to expand the expertise within the Forum working with subject matter experts as forum ambassadors.

### Reflections in 2023: (Outputs and outcomes)

The forum has focused on building as a steering committee, gaining understanding and confidence in roles, responsibilities, and networking with other organisations. Monthly committee meetings have been established with a standard agenda enabling feedback from all committee members and continuing the momentum in developing and promoting the forum. A focus throughout the year has been the updating the ECA level 1 and 2 competencies to ensure they are meaningful, practical, and valid for our members; ensuring they meet the ever-evolving needs of Emergency care nurses.

The Steering committee met in March 2023 to develop Forum Strategy. One of our key priorities continues to be increasing communication with our forum members, including the use of social media. The Facebook page is now regularly updated by one of the committee members and there are currently 1,381 members on our Facebook group. The Twitter account was relaunched and currently has 94 followers, there were issues with the old Twitter account which the media team are aware of but are outside the control of the committee.

The Steering committee is currently finalising the ECF Level 1 and 2 competencies with the support of other relevant forums and colleagues. Once completed the plan is to develop Level 3 competencies and investigate the feasibility of a digital platform.
