Introduction

The General Practice Nursing Forum represents members working in General Practice at local, regional and national level. We aim to raise the collective voice of General Practice Nurses (GPNs), taking forward the issues and challenges that they are facing as a daily occurrence. GPNs play a crucial role in delivering a high-quality service in primary care, we strive to raise the profile of GPNs to



ensure they receive the recognition they deserve, and we support GPNs professional learning and development. Based on membership feedback, our focus over the last year has prioritised workforce development and Fair Pay for GPNs, we have represented the GPN voice across key stakeholders including NHS England and the BMA. Our future work aims to build on our achievements by influencing policy makers and forging partnership working to continue to raise our profile at the highest level.

Membership of the forum

The GPN Forum remains one of the larger forums at the RCN and we seek to fully represent the four Countries of the United Kingdom.

Total number of members

The overall trend has been an increase in membership during the past 12 months. We have continued to grow and develop as a forum to 9817 members as of November 2024, including 6204 as 1st choice. This is an increase of 5.8% increase from last year.

Committee membership

The committee represents all areas of general practice nursing in advanced clinical practice, leadership and education as well as NHS Resolution and Local Medical Committee. The forum is well placed to advise and support our membership in their professional and clinical roles. The committee was one member short during 2024 due to an early resignation for personal reasons (6 instead of 7 members).

Four vacancies become available for January 2025 onwards, and we had eight applications, which resulted in six interviews for forum vacancies. Sarah Hall and Penny Sibthorp were successfully interviewed and reappointed to the forum. Frances Baverstock and Sara Baldwin successfully interviewed and have been appointed to the forum for a tenure of four years. Due to the calibre of the candidates, two further interviewees were offered a link nurse role with the forum once governance arrangements have been established, hopefully in early 2025.

We have had 3 different professional leads to date this year, and a change in Chair and Vice-Chair positions.

Facebook: Continued growth on Facebook now 7018 members (6802 in 2023). 2 members of the steering committee are page administrators and moderators requiring daily moderation and approval of posts. The page provides a platform for sharing Forum activities and RCN activities/events as well as promoting lively debate. In October there were 120 posts with 4,021 active members. Most common and active themes are vaccinations and pay, terms and conditions. New FB guidance was added this year to aid professional networking and moderation.

- Collaboration with NHS England and National Association of Primary Care (NAPC) in running the GPN Forum monthly updates for general practice nurses all forum members contribute and update forum members on a monthly rota (All)
- This year the focus of some of our work has been looking at standardising job descriptions and person specification for nursing roles within general practice, with the aim of supporting GPNs in the future to have those influential conversations with an underpinning of a skills knowledge framework that is pertinent to them. This has been a large piece of work and has involved looking at multiple JDs across a number of AFC bandings in order to get a sense of what is being expected for each job role and shown a wide variety and difference with little consistency. We are now in the process of collating information for each level of nursing from Nurse Associate, Registered Nurse, Enhanced Level and Advanced Level. This work will continue into 2025 (PS, SH, KB)

- Collaborated with The Woman's Health Forum on the production of new guidelines for nurses on cervical screening and physical disability (LDF)



Main highlights of the year

The GPN forum have made significant progress on some of their workstreams in 2024, highlights include:

 Joint webinar in collaboration with the Legs Matter Coalition – Can GPN's stop Leg ulcers in their tracks - over 220 attended the webinar, raising awareness on the importance of early intervention in lower limb care (PS, KS, LDF) <u>Can GPNs stop leg ulcers in their tracks? - Legs</u> Matter Webinar





- Supporting Mental Health in Adults with Long Term Conditions- Joyce has been working with Education for Health and the University of Hertfordshire to develop a Level 6 module for GPNs and community nurses. The online module is now live on the Education for Health website, with the first cohort, hopefully, running in January 2025 (JP)
