Forum Name: Pain and Palliative Care Forum

Introduction:

This very active Forum provides expert guidance, education, and support for all members. It also has and continues to develop guidance and tools to support the nursing teams providing care to patients in all healthcare settings. The main areas that we cover include acute, chronic (persistent) and procedural pain, supportive care, symptom control, advance care planning and end of life care.

Early in the year we attempted to recruit to the 2 vacant positions within the forum, there was 4 applications only 2 of which were suitable for interview. At interview it was felt that the two candidates did not meet the requirements for a position on the steering committee however they were encouraged to become more involved and familiar with the work of the forum to support a future application. At the second round of forum appoints there was significantly more applications and this led to the appointment of two new forum members that will start their term of office in January 2023. Martin Galligan was reappointed and will continue for a second term and continue in the role of chair.

Reflections on 2023: (Outputs and outcomes)

During 2023 the forum has continued to work extremely hard despite having 2 vacant positions. The key outputs from the forum in 2023 include:

Webinar: In early 2023 we hosted our first live webinar with a focus on introducing the wider membership to the forum steering committee. The webinar was split into two parts, the first was an overview of the work of the forum and the second focused on education content on having difficult conversations. There was 120 live delegates in attendance at the webinar and the recording has been placed on the forum website.

Blogs: We have established a blog schedule to ensure that we are producing content throughout the year on various topics relating to pain and palliative care. This has enabled the forum to keep the wider membership updated.



Pain Assessment in Learning Disability Project: Sandra Campbell has been leading the work of this project and in 2023 had this approved by FGG. The project is now progressing to plan with an extensive stakeholder network from across the four nations supporting this project.

Mouthcare Matters: Suzanne Monks continues to lead this extensive project in conjunction with Marie Curie. The outputs for this project have included the publication of two documents and education material in combination with Marie Curie.

UK Career Framework for Pain Nurses: Martin Galligan has been leading the work of this project and was able to gain endorsement from The British Pain Society and the Pain Nurse Network. This resource is now fully available via the forum webpages.

Congress attendance: This year the forum steering committee were all able to attend congress and take part in activities to promote the work of the forum. This included a meet the forum session and attendance at the world café.

Forum Link Nurses / Stakeholders groups: Martin Galligan has been leading on this work to improve engagement with the wider forum membership. The aim is to set up two groups to support the work of the forum:

Pain link nurses: This is open to all forum members from across all levels of nursing practice. The aim is to promote good practice in pain and palliative care nursing within their areas and support the work of forum. We held the first link nurse meeting in December 23 with 19 link nurses coming forward. They represent a range of clinical backgrounds and levels of practice.

Stakeholder Group: The goal of the stakeholder group is to bring together experts from across pain and palliative care nursing to support the work of the forum in commenting on and informing national documents in relation to pain and palliative care nursing. The group has been identified by the forum steering committee with the first meeting being planned for December 23.

Getting it right every time- Fundamentals of Nursing care at the end of life: (developed on information in 2014. Will now be revised and relaunched after a complete overhaul through FFG submission and action plan going forwards led by Suzanne Monks and the wider committee in 2024. For now, it is archived. Discussion concluded by Suzanne and Ola
