#### Introduction:

The Public Health Forum promotes the value public health nursing, ranging from travel health, immunisation, TB, sexual health, HIV, health protection and occupational health. It is essential to promote good health and protect against ill health for individuals, communities and across the population.

We believe that all nurses, midwives, health practitioners and students should utilise the principles of public health wherever they work. We work to raise awareness, respond to consultations, provide and support educational events, publish competency frameworks and guidance and provide a range of resources on the RCN website.

In 2023 the forum has had a busy and productive year. The focus has shifted from the recovery after the global pandemic of COVID-19, to the cost-of-living crises.

At the start of the year the steering committee had a full complement of members (six). The committee members come from a range of public health areas to reflect a wide area of public health practice.<sup>1</sup> One member left at the start of autumn, due to personal reasons. With already having a vacancy, this brought it to two. We received 4 applicants for 2 places, and have appointed 2 new members to join from January 2024, taking it to full establishment. There were no applications for the chair role, therefore the current chair will extend their term to another year, bringing their term end part of the committee to end in December 2024.



The annual strategy planning meeting was held virtually on 24<sup>th</sup> April 2023. The aim is to have this in person next year during 2024. However, the catch-up meeting with the steering committee members will remain being held on Microsoft teams.

The forum also agreed to ensure all members of the committee have their profile on the forum webpage. This is alongside an extended list of contacts from the wider public health forum. These colleagues have particular skills and expertise, and their role and biographies are also represented on the forum page. They have supported the forum and the wider public health work of the RCN with; specific projects, alliance membership to various stakeholder groups and in helping to keep the various public health related clinical topic pages up to date. It will be revised next year to reflect new members.

- Matter of discussion: That this meeting of RCN Congress discusses the successes and learning from the current Fair Pay for Nursing campaign. TQ+ hate crime
- Resolution: Health care success for refugees and asylum seekers: passed
- Fringe: Climate/sustainability
- Fringe: Palliative care / community (loneliness) public health perspective
- The forum also participated and led on the organising of the world café, with the nursing department at the RCN.
