Forum Appointment

At the start of the year the steering committee had a full complement of members (six). The committee members come from a range of public health areas to reflect a wide area of public health practice.¹

Two spaces on the committee, were vacant for the start on January 2025, the chair's and two committee members. All 3 spaces have been filled. One was a current member, extended for further 2 year. Existing member appointed into the chair's role, commencing January 2025. One new member appointed, from background of sexual health, who will join also join in January 2025.

The Committee received 13 eligible applications for the 2 vacancies for the 2024 forum appointments.



The annual strategy planning meeting was held hybrid on 05 February 2024.

The forum committee members have their profiles on the webpage, this will need revising next year (2025). The webpage also includes list of extended contacts from the wider public health forum. These colleagues have particular skills and expertise, and their role and biographies are also represented on the forum page. They have supported the forum and the wider public health work of the RCN with; specific projects, alliance membership to various stakeholder groups and in helping to keep the various public health related clinical topic pages up to date. It will be revised next year to reflect new members.
