

RCNXtra Members Giveaway – Terms and Conditions

1. Introduction

These terms and conditions apply to the “RCNXtra Members Giveaway” (the “Competition”) organised by Next Jump Limited (“Organiser”) and promoted in collaboration with the Royal College of Nursing (RCN). By entering the Competition, participants agree to be bound by these terms and conditions.

2. Eligibility

- The Competition is only open to members of the Royal College of Nursing (RCN) who are registered with RCNXtra and are residents of the United Kingdom aged 18 years or over.
- Employees of the Organiser, the RCN and their immediate families are not eligible to enter the Competition.

3. How to Enter

- Entry is free and no purchase is necessary.
- Participants may enter by:
 - Logging into the RCNXtra Perks at Work app. If the app has not yet been downloaded, participants can download the Perks at Work app from the App Store or Google Play and then log in to their account.
 - Only one entry per person is accepted. Duplicate entries will be disregarded.
 - Entries must be made in accordance with the instructions provided as part of the promotional materials for the Competition.

4. Competition Period

- The Competition opens at 00:01 BST on 26 February 2026 and closes at 23:59 BST on 8 March 2026.
- Entries received after this time will not be eligible.

5. Prizes

- There are 10 prizes available, each consisting of two cinema tickets, one large popcorn and two drinks, redeemable at either Cineworld or Odeon.
- Each winner will receive one prize.
- Prizes are non-transferable and no cash alternative will be offered.

- Winners will be selected via a random draw conducted fairly, transparently and impartially, within 30 days of the closing date.
- Winners will be contacted by email using the details associated with their RCNXtra account.
- If a winner cannot be reached or does not respond within 10 days, the Organiser reserves the right to select an alternative winner.

- By entering the Competition, participants consent to the Organiser using their name for the purposes of announcing the winner of the Competition.
- Any personal data provided by participants will be used solely for the administration of the Competition and in accordance with applicable UK data protection legislation and [Next Jump's Privacy Policy](#).
