# Exploring Clinical Research Nurses' experiences of working with Clinical Nurses

**Summary:** This presentation will detail the findings of a doctoral study which explored the experiences of ten Clinical Research Nurses (CRNs) in relation to building positive relationships with

clinical nurses. The study indicated that CRNs value their relationship with clinical nurses and that this relationship assists in conducting successful clinical research and confirming the importance of the CRN role. However, there appear to be some difficulties that should be addressed to further enhance this relationship. Recommendations will be made to assist in this process.

#### Benefits of a 24/7 research recruitment model

Patients can become eligible for inclusion in research studies at any time of the night or day and on day of the week. Adopting a staffing structure that recognises this has several benefits including maximising recruitment into research studies, ensuring adherence to study protocols and facilitating the public involvement in research.
