RCN Foundation Benevolent Fund funding for nurses affected by the floods

Nursing staff affected by the recent floods in Cumbria can apply for hardship funding from the RCN Foundation Benevolent Fund.

Trustee of the RCN Foundation and RCN Council Member Ian Norris joined RCN Cumbria branch Chair Billy Drysdale (pictured right) before Christmas to visit local nurses rebuilding their lives and communities following the storms.

Ian Norris said: "Nursing staff provide essential care for patients all year round, but it is during times of

disaster their skills and qualities really shine through. These floods have taken the homes and security of many of our nurses, yet they have dedicated themselves to caring for those in need and helping to repair their communities.

Thousands in Cumbria had to be evacuated from their homes when devastating floods struck on several occasions this December.



Nursing staff were among the victims of the floods, many having to leave their

homes while others worked extra shifts helping those affected. They also played a vital role caring for patients and maintaining safety in hospitals left without power, such as at the Cumberland Infirmary (some of whose A&E Department staff are pictured left with Ian Norris) to witness the damage inflicted by the storms and the immense of contribution of nursing staff to the recovery efforts.

Among other sites, Ian's visit also took in the Mary Hewetson Cottage Hospital in Keswick (senior staff nurse there Lesley Primrose and receptionist Louise Roscamp are pictured left). "I'm delighted that we will be able to help these nurses to move forward with their lives," continued Ian. "The Benevolent Fund was developed for this exact purpose; to help nurses to rebuild following difficult situations and to thank them for their valuable contributions to society."







RCN calls for halt to closure of Hartlepool's fertility treatment unit

Following the recent announcement that, due to recruitment problems, North Tees and Hartlepool NHS Foundation Trust is closing its IVF and fertility treatment unit at Hartlepool, the RCN can reveal that the trust only has advertised the current vacancy once, in September, and then for only a week, on the NHS Jobs website.

Last week, the trust said: "We have made every effort for some time to recruit, however we cannot continue to provide all aspects of the current service safely due to an inability to recruit embryologists."

RCN Northern regional director Sarah Dodsworth said: "The trust has stated that one of the main reasons for closing the unit is because they are struggling to recruit to the position of embryologist. And yet, they were successful at recruiting to this post as recently as May 2015."

She added: "Since the post became vacant, they have only advertised the position once, in September, and even then it was only advertised on the NHS jobs website for a week. To abolish a successful, high quality unit, and put a number of our members - who are excellent nurses - at risk of redundancy based on a failure to recruit to a post after advertising it only for a week, is clearly unacceptable."

"We know that the NHS struggles to recruit currently, but no attempt has been made to advertise the post for a reasonable amount of time, or further afield, or to recruit from abroad. The trust must put this decision on hold until it undertakes a full and transparent consultation with the broader community and stakeholders."
