CAN I USE THIS FOR CPD?

Ways that you are already gathering CPD for Revalidation.



WHAT'S REQUIRED?

You must have undertaken 35 hours of continuing professional development (CPD) relevant to your scope of practice as a nurse or midwife in the three year period since your registration was last renewed, or when you joined the register.

Of those 35 hours of CPD, at least 20 must have included participatory learning.



WHAT IS PARTICIPATORY CPD?


To meet the participatory learning requirement, you simply have to undertake activity that involves interaction with one or more other professionals. This can be in a physical environment or a virtual one – you don't have to be in the same room as the people you undertake the activity with.

DISCUSSION GROUPS

- Journal groups- a Meeting of 2 or more Nurses discussing a piece of research. This could be colleagues at work or other professionals as long as it is relevant to practice.
- Staff Meetings- Any kind of staff meeting that discusses practice. This can include changes in procedure or reviews of Datix and incident forms.
- RCN Forums- 36 different forums which are excellent for networking if your area of nursing is niche.
- RCN Branch meetings and Congress.- We are currently researching what members want from Branch meeting and what learning events are wanted.



Tweeting & Revalidation

Tweeting can be a great way for nurses to gain participatory CPD hours

Twitter is a free & easy to use resource that allows you to join in conversations about nursing practice

Tweetchats usually take place in the evenings and subject matter is as wide & diverse as nursing itself. All you have to do is log on to Twitter at the right time & search for the relevant hashtag to find the conversation

And if you miss the Tweetchat there is always a summary posted afterwards that you can read and add to your CPD too

After the Tweetchat if you go to wecommunities.org/mytwe & sign in using your Twitter details you can reflect on the Tweetchat you took part in and download that reflection as a PDF to add to your Revalidation Portfolio

SECONDMENT OR SHADOWING



- Evidence of participation including signed letters, notes, observations and outcomes
- Able to use Revalidation to learn new skills and potentially further your career.

HOW TO SUBMIT CPD

You must maintain accurate records of CPD you have undertaken. These records must contain:

- ✓ the CPD method
- ✓ a description of the topic and how it related to your practice
- ✓ the dates on which the activity was undertaken
- ✓ the number of hours
- ✓ the identification of the part of the Code most relevant to the activity
- ✓ evidence that you undertook the CPD activity

WRITTEN REFLECTIVE ACCOUNTS.

A quick guide to reflection



WHAT DO WE NEED TO DO?

- 5 Reflective Accounts over 3yrs.
- The accounts can be on any subject that is relatable to your practice.
- The Account has to be relatable to the NMC Code of Conduct.
- It can be a reflection on CPD, Feedback or and Event




HOW DO I REFLECT?

Good chance you are already doing it!

- On the bus.
- Before bed.
- In a diary.

We are often reflecting informally without realising it.



HOW DO I REFLECT?

Subjects for reflection

An instance of CPD:

This could be any of the things we talked about in the last section.

It can be a reflective review of a lecture or talk from a visiting specialist.

It could be a reflection of a departmental meeting.

It could be a reflective piece on an article about your area or care.

A Piece of practice related feedback:

This can be a piece about how you feel that you have improved your practice after some feedback.

This could be a reflective piece on how what you feel are your strengths in a piece of feedback and how you think you can expand on that.

An event or experience in your own practice.

This can be an event that impacted you positively or negatively.

It may be an example of outstanding care that you have given.

Or it could be something that you felt you could have done better.

REFLECTIVE ACCOUNTS FORM

You must use this form to record five written reflective accounts on your CPD and/or practice-related feedback and/or an event or experience in your practice and how this relates to the Code. Please fill in a page for each of your reflective accounts, making sure you do not include any information that might identify a specific patient, service user or colleague. Please refer to our guidance on preserving anonymity in Guidance sheet 1 in *How to revalidate with the NMC*.

What did you learn from the CPD activity and/or feedback and/or event or experience in your practice?

How did you change or improve your practice as a result?

Select one or more themes: Prioritise people – Practise effectively – Preserve safety – Promote professionalism and trust

HOW DO I REFLECT?

We must use the NMC's reflective accounts form.

But this makes it really easy as you know exactly what information is needed!

REFLECTIVE DISCUSSION

- You must have had a reflective discussion with another NMC registrant, covering your five written reflective accounts on your CPD and/or practice-related feedback and/or an event or experience in your practice and how this relates to the Code.
- You must ensure that the NMC registrant with whom you had your reflective discussion signs the approved form recording their name, NMC Pin, email, professional address and postcode, as well as the date you had the discussion.

REFLECTIVE DISCUSSION

Who can do my reflective discussion?

- It usually is your manager and can be the same person who is doing your confirmation.

If you don't have someone like this or if your manager isn't an NMC registrant, it could be:

- a colleague you work with regularly, or with someone you are less familiar with.
- you might find it more helpful to discuss your reflective accounts with someone who has had similar experiences to you, or someone with different experiences.
- they could be senior or junior to you, or at the same level: would you find it valuable to have insight from someone who has been working at a different level to you?

HOW TO GET THE MOST OUT OF YOU REFLECTIVE DISCUSSION?

Think of it as an opportunity to:

- to share ideas, information and experiences
- to debrief after an incident
- to get another person's perspective on a situation
- to think about professional development objectives.
- Can you identify any areas in the reflective accounts that you haven't considered?
- Have you focused exclusively on the positive feedback, events or experiences in practice with no evidence of constructive criticism or learning?

REFLECTIVE DISCUSSION FORM

You **must** use this form to record your reflective discussion with another NMC-registered nurse or midwife about your five written reflective accounts. During your discussion you should not discuss patients, service users or colleagues in a way that could identify them unless they expressly agree, and in the discussion summary section below make sure you do not include any information that might identify a specific patient or service user. Please refer to Guidance sheet 1 in How to revalidate with the NMC for further information. This form should be completed, stored and shared in manual paper form, as opposed to electronically. This is important because creating, storing or sharing these data electronically may trigger an obligation to register with the Information Commissioner. For this reason this form is not editable.

REFLECTIVE DISCUSSION

- You must use the NMC's Reflective discussion form that they have produced.
- Although you are not required to submit this form to the NMC at any point, you should keep it safe as part of your records.
- You may choose to store the completed confirmation form in either paper or electronic format.



HEALTH AND CHARACTER

- You must provide a health and character declaration.
- You must declare if you have been charged, convicted of any criminal offence (including a conditional discharge) or issued with a formal caution.
- You will be asked to declare if you have been subject to any adverse determination that your fitness to practise is impaired by a professional or regulatory body (including those responsible for regulating or licensing a health and social care profession)



PROFESSIONAL INDEMNITY ARRANGEMENT

- This is usually covered by your Employer in the form of Vicarious Liability.
- If you are not employed but the NHS please check this out.
- If you are not covered by your employer you are covered by your RCN membership. Search Professional indemnity on the RCN Website for more details.

CONFIRMATION

- The NMC will ask you for information for the purpose of verifying the declarations you have made in your application.
- This will be a declaration in which you have demonstrated to an appropriate confirmer that you have met the revalidation requirements. The NMC have provided a form for you to use to obtain this confirmation.
- They will ask you to provide the name, NMC Pin or other professional identification number (where relevant), email, professional address and postcode of the confirmer.

CONFIRMATION

Who can be my Confirmer?

- This is the person who looks at the evidence you have collected and 'confirms' that you have met the revalidation requirements.
- Where possible, your confirmer should be your line manager.
- Your confirmer does not need to be a registered nurse, midwife or nursing associate.
- Does not need to be the same person you had your reflective discussion with, although this can often be a sensible choice as it makes the process a little easier.

CONFIRMATION FORM

You **must** use this form to record your confirmation. This form should be completed, stored and shared in manual paper form, as opposed to electronically. This is important because creating, storing or sharing this data electronically may trigger an obligation to register with the Information Commissioner. Please refer to Guidance sheet 1 in *How to revalidate with the NMC* for further information. For this reason this form is not editable.
